

## COMPANIES ACT 2016

The Companies Act, 1965, which had regulated Malaysian companies since time immemorial, have been replaced by the new Companies Act, 2016 ("CA2016") and the Companies Regulations, 2017 with effect from 31 January 2017. Compliance with CA2016 and the 2017 Regulations is mandatory for ALL companies with effect from that date.

This ½-day workshop will highlight the main game-changers under the CA2016, new formation and administration processes, and corporate governance provisions, as well as the new prohibitive penalties for non-compliances with the Act.
